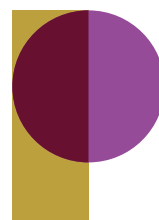

Step One

Instruct Plumlife Move to sell your home

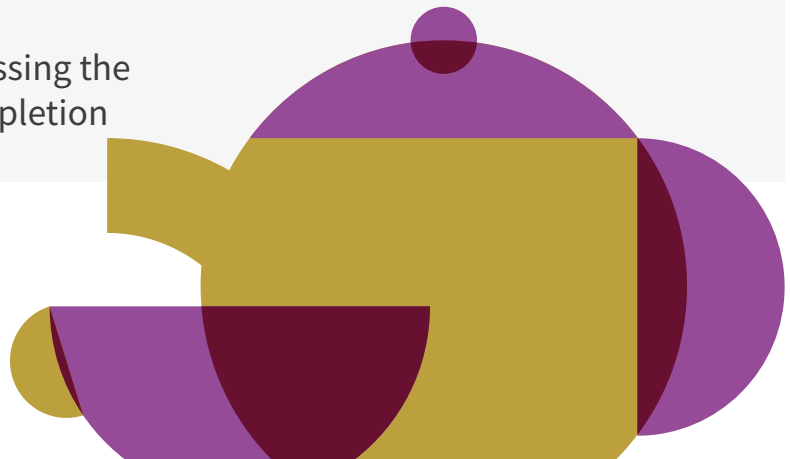
If you have decided you want to sell your Shared Ownership home, first make contact with the housing provider that owns the other share of your home and then reach out to us afterwards on **move@plumlife.co.uk** or **0161 447 5050**.

Step Two

Get a valuation

You will need to get a valuation from a Qualified Chartered Surveyor (MRICS or FRICS) to help you understand what the value of your home might be. All Shared Ownership homes must be sold on the basis of an independent RICS valuation.

RICS is the Royal Institution of Chartered Surveyors. The sale price will be based on the value they provide and your housing provider will need to approve this.

Our Shared Ownership experts will help you through this process but there's a few things you'll need to have ready:

- Your EPC
- Details of your lease
- Proof of home ownership and the contract you have with your housing provider

Step Three

We market your property

Here's how we do that:



We find out about your home to help create a listing

We will speak to you to find out everything we can about your home, and then write a listing about your property that sells it in the most exciting and relevant way. We will also take brand new photos of your home that show it in the best light!



Advertising your home

We advertise your home on various property websites, including our own brand-new website and on Rightmove. We will also promote your home via social media.

Step Four

We sell your home

We'll work hard to find an eligible buyer and then work together with you and your solicitors to sell your home and complete the sale. We've outlined the process below but your dedicated Plumlife Move representative will always be there to talk you through the process.

1

You appoint a firm of solicitors to act for you.

We produce a Memorandum of Sale with all the details of the sale and write to:

- you
- your solicitor
- your buyer
- your buyer's solicitor
- your landlord's solicitor

2

Your buyer's solicitor checks the paperwork from your solicitor and gets answers to any questions. Your Plumlife Move representative will be there throughout this step to communicate with everyone, to move the process along and offer any advice around Shared Ownership nuances.

3

Your buyer works with their financial adviser to get a mortgage approved.

4

Your solicitor lets you know when contracts are ready to be exchanged and you agree a completion date that suits you and your buyer.

5

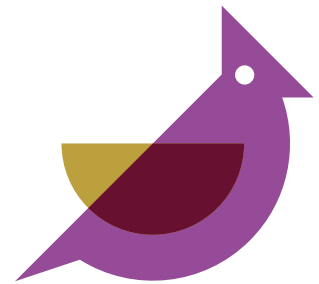
We'll give your solicitor a completion statement that sets out what you've already paid what you need to pay, e.g. outstanding ground fees.

We'll help you arrange the best time and place to hand keys over to your buyer.
